BKI engages consultants for services for which the Institute does not have the required specialist skills. The total consultancy costs incurred during 2020 was \$3.43M million (excl. GST).

There were 23 consultancies where the total fees payable to the consultants were less than \$10,000. The total expenditure incurred during 2020 in relation to these consultancies was \$102,000 (excl. GST).

There were 35 consultancies where the total fees payable to the consultants were \$10,000 or greater. The total expenditure incurred during 2020 in relation to these consultancies was \$3.34M (excl. GST).
